Join the Childcare Vouchers scheme before it closes to new entrants on 4th October to save up to £933/year on childcare costs

The scheme will be **closed to new entrants on 4th October**, due to the roll out of the new Government scheme, Tax-Free Childcare (TFC).

But don't worry, there's still time for you join through.

You will you need to have your first wage adjustment and be in receipt of vouchers before midnight on 4th October 2018. Check with your employer when the final cut-off date for joining is in your organisation in order for them to apply this adjustment to your wages in time.

Why join the scheme now?

- 1. Childcare Vouchers can help you save up to £933/year, per parent on your childcare costs, through tax and NI savings.
- 2. They can be used to pay for care for children aged up to 15, or 16 if disabled. They can be used for a wide range of childcare, including childminders, nurseries and afterschool clubs.
- 3. Many families will be better off staying on the Childcare Vouchers scheme. If you're not sure which scheme is best for you, join now to keep your options open in the future. You only need to contribute the minimum amount.
- 4. By joining before the cut off date, you can continue to benefit from the savings for as long as your child remains eligible, you stay with the same employer, and have had a wage adjustment and received vouchers within the last 12 months.
- 5. Any vouchers you accumulate in your account will not expire and can be used, even if you decide to switch to TFC at a later date. Please be aware though that you cannot benefit from both schemes at the same time.
- 6. Childcare Vouchers can be used in conjunction with 30 hours free childcare for 3-4 year olds.

I already receive Childcare Vouchers; do I need to do anything?

If, when the scheme closes to new entrants on 4th October 2018, your wages will not have been adjusted and vouchers received within the last 12 months or more, you'll need to agree with your employer to have a wage adjustment and receive new vouchers by midnight 4th October 2018 to remain eligible to stay on the scheme.
